#### 1. Who we are

This privacy policy applies to:

For the purposes of the General Data Protection Regulation (GDPR / AVG), we are the data controller.

## 2. What personal data we process

We process personal data that you provide to us directly, including:

- Name, email address, phone number
- Date of birth
- Invoicing details
- Intake information
- Therapy notes
- Communication related to your sessions
- Information concerning your mental health (special category data)

We only collect data that is necessary for providing therapy and related administrative purposes.

## 3. Purpose and legal basis for processing

Your personal data is processed for the following purposes:

- Providing psychological therapy or coaching
- Managing appointments and communication
- Maintaining client records
- Invoicing and administration

Complying with legal and professional obligations

The legal bases under GDPR are:

- Performance of a contract (therapy services)
- Explicit consent (for processing health data and online sessions)
- Legal obligation (administration and tax requirements)

## 4. Special category (health) data

Therapy involves processing special category personal data under Article 9 GDPR.

This data is processed only with your explicit consent and handled with appropriate confidentiality and security measures.

#### 5. Online sessions

Online sessions may take place via Zoom, a video-conferencing provider.

- Zoom acts as a data processor
- A Data Processing Agreement (DPA) is in place
- Sessions are not recorded
- Security measures such as passwords, waiting rooms and encryption are used

Zoom is a US-based company. Personal data may be transferred outside the EU under Standard Contractual Clauses (SCCs) and additional safeguards.

You may request an alternative (e.g. phone or in-person session) at any time.

## 6. Sharing of personal data

Your data is not shared with third parties, unless:

- This is necessary for the provision of services (e.g. video platform)
- Required by law
- You have given explicit consent

Your data is never sold or used for marketing purposes.

#### 7. Data retention

Personal data is retained no longer than necessary.

- Client records are retained in line with professional and legal requirements
- Invoicing data is retained according to Dutch tax law
- Video sessions are not recorded or stored

## 8. Security measures

We take appropriate technical and organisational measures to protect your data, including:

- Secure devices and passwords
- Encrypted communication where possible
- Restricted access to client information
- No cloud storage of therapy recordings

## 9. Your rights

Under the GDPR, you have the right to:

- Access your personal data
- Rectification of incorrect data
- Erasure (where legally possible)
- Restriction of processing
- Data portability
- Withdraw consent at any time
- Object to processing in certain cases
